Based on the documentation and information provided to the COC, as referenced herein, the COC has found, pursuant to Education Code Section 15278(b)(1) that the expenditures of Measure G Series A Bond funds have been made by the School District on costs, expenses and construction/acquisition/installation costs of projects authorized by Measure G.

- No Measure G monies have been spent on teacher/administrator salaries or other school operating expenses (Education Code Section 15278(b)(2).
 Based on the documentation and information provided to the COC, as referenced herein, the COC has found, pursuant to Education Code Section 15278(b)(2) that the School District has not expended Measure G Series A Bonds funds on teacher/administrator salaries or other District operating expenses.
- 6. The COC has received all necessary and requested technical and administrative assistance from the School District (Education Code Section 15280).

 Under the requirements of Education Code Section 15280, the School District is required to provide the COC with all necessary technical and administrative assistance without expending Measure G Series A Bond funds. The School District has made presentations to the COC, provided documents and information as set forth herein, and has provided necessary and requested architectural, construction management, legal and planning support and assistance to the COC. Based on the foregoing, and the documentation and information provided to the COC, as referenced herein, the COC has found that the School District has provided all necessary and requested technical and administrative assistance without expending Measure G Series A Bonds funds.
- 8. <u>COC Website is operating and includes all required documentation and information (Education Code Section 15280(b)).</u>
