10. <u>NEW BUSINESS</u>

a. Recommendation is submitted to approve the Tentative Agreement between California School Employees Association (CSEA) & its Savanna Chapter 322 and the Savanna School District. The tentative agreement includes the following language:
For 2022-23, the Classified Employees Salary Schedule will be increased by an additional four percent (4%), effective July 1, 2022. This is in addition to the 1% increase to the classified salary schedule applied effective July 1, 2022, as a result of the Tentative Agreement signed on December 20, 2021, for a total salary schedule increase of five percent (5%) to the classified salary schedule effective July 1, 2022. Additionally, unit members in paid status with the District as of September 30, 2022 will receive a one-time off schedule salary payment of five percent (5%) for the 2022-23 school year. This is in addition to the 1.5% one-time off-schedule payment to be applied effective July 1, 2022, as a result of the Tentative Agreement signed on December 20, 2021. The above 5% off-schedule payment, when combined with the above 1.5% off-schedule payment will result in a total off-schedule payment of six and a half percent (6.5%) for the 2022-23 school year. b. Recommendation is submitted to approve the increase of the confidential and management salary schedules by an additional four percent (4%), effective July 1, 2022. This is in addition to the 1% increase to the confidential and management salary schedules applied effective July 1, 2022, for a total salary schedule increase of five percent (5%) to the confidential and management salary schedules effective July 1, 2022 reflecting a salary increase equivalent to that for CSEA. Additionally, confidential and management employees in full paid status with the District on September 30, 2022 will receive a one-time off schedule salary payment of five percent (5%) for the 2022-23 school year. This is in addition to the 1.5% one-time off-schedule payment to be applied effective July 1, 2022. The above 5% off-schedule payment, when combined with the above 1.5% off-schedule payment will result in a total off-schedule payment of six and a half percent (6.5%) for the 2022-23 school year, reflecting an off-schedule payment equivalent to that for CSEA.
